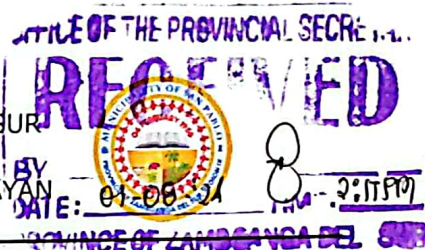

EXCERPT FROM THE MINUTES OF THE 42ND REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON AUGUST 16, 2023.

MUNICIPAL ORDINANCE NO. 23-11

"AN ORDINANCE ABOLISHING THE POSITION OF AGRICULTURAL TECHNOLOGIST, SALARY GRADE 10 UNDER THE OFFICE OF THE MUNICIPAL AGRICULTURIST, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, this August Body recognizes the need for efficient resource utilization and effective management of positions within the municipality;

WHEREAS, reviewing the administrative structure of various offices, it has been determined that abolishing the position of Agricultural Technician, SG 10 under the office of the Municipal Agriculturist will streamline organizational operations and enhance overall efficiency;

WHEREAS, funding for Agricultural Technician, SG 10 can be used and distributed to some personnel and for creation of relevant position in the same office.

NOW THEREFORE, BE IT ORDAINED by the 11TH Sangguniang Bayan of San Pablo, Zamboanga del Sur on its 39TH Regular Session held at the Municipal Session Hall on July 26, 2023 at 9:00 o'clock in the morning that:

Section 1. The position of Agricultural Technologist under the office of the Municipal Agriculturist is hereby abolished effective August 16, 2023.

Section 2. The personnel assigned to this position had retired from the service, effective October, 2022;

Section 3. Any Rules, regulations, or ordinances in conflict with the provisions of this ordinance are hereby repealed, revoked, or modified to the extent necessary for the proper implementation of this ordinance.

Section 4. This ordinance shall take effect immediately upon approval.
