## **APPROPRIATION ORDINANCE NO. 23-2023**

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIFTEEN THOUSAND PESOS (P15,000.00) FROM THE APPROPRIATION FOR OTHER SUPPLIES EXPENSES UNDER THE OFFICE OF THE MUNICIPAL BUDGET OFFICER, SAN PABLO, ZAMBOANGA DEL SUR TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for REPAIR AND MAINTENANCE OF IT EQUIPMENT under the Office of the MBO, San Pablo, Zamboanga Del Sur, for CY 2023;

Section 2. The total amount of FIFTEEN THOUSAND PESOS (P15,000.00) shall be transferred to wit:

**Section 3.** Transfer/Augment of Item. **Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan, this 6<sup>th</sup> day of September, 2023, during the 45<sup>th</sup> Regular Session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
