## **APPROPRIATION ORDINANCE NO. 23-2025**

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIFTY-SEVEN THOUSAND SIX HUNDRED NINETY- FOUR PESOS (P57,694.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES; PRINTING AND BINDING EXPENSES; OTHER MOOE; AND REPAIR & MAINTENANCE – IT EQUIPMENT UNDER THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR (MPDC) TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for OFFICE SUPPLIES; PRINTING AND BINDING EXPENSES; OTHER MOOE, and REPAIR AND MAINTENANCE – IT EQUIPMENT under the office of the MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR (MPDC), San Pablo, Zamboanga del Sur;

Section 2. The TOTAL AMOUNT of FIFTY THOUSAND PESOS (P50,000.00) shall be transferred/augmented to wit;

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
