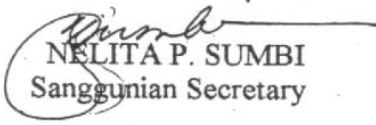
Section 2. Amendments to this ordinance shall take effect only when

supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.

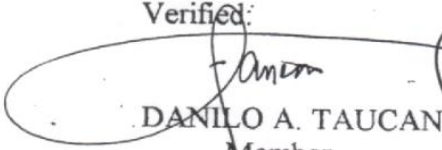
