APPROPRIATION ORDINANCE NO. 05-0403

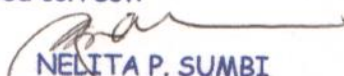

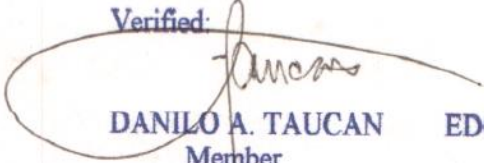
