Section 1. Out from the total savings of One hundred fifty four thousand
eight hundred eight pesos and twenty five centavos
(P154,808.25) from the vacant position of Bookkeeper and
Municipal Accountant, the total amount of One hundred fifty
thousand pesos (P150,000.00 is hereby properly appropriated for
the following:

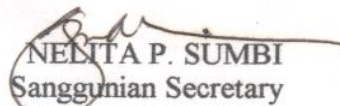
a. Publication of Revised Municipal Revenue Code	150,000.00

enforce.

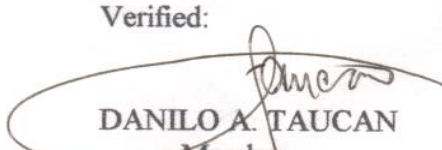
