EXCERPT FROM THE MINUTES OF THE 66TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON FEBRUARY 14, 2024.

MUNICIPAL ORDINANCE NO. 26-11

"AN ORDINANCE ABOLISHING THE POSITION OF AGRICULTURAL TECHNICIAN I, SALARY GRADE VI, UNDER THE OFFICE OF THE MUNICIPAL AGRICULTURIST, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, the municipality of San Pablo, Zamboanga del Sur recognizes the importance of an efficient and effective agricultural sector in promoting rural development and ensuring food security for its residents;

WHEREAS, the municipality constantly evaluates its organizational structure to enhance the delivery of agricultural services to its constituents;

WHEREAS, after thorough assessment and review of the existing positions within the office of the municipal Agriculturist, it has been determined that the duties and responsibilities previously assigned to the position of Agricultural Technician I, Salary Grade VI, are redundant and can effectively be performed by other existing positions;

WHEREAS, in order to streamline the organizational structure and maximize the utilization of resources, it is necessary to abolish the position of Agricultural Technician I, Salary Grade VI.

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR, IN SESSION ASSEMBLED:

Section 1. The position of Agricultural Technician I, Salary Grade VI under the office of the Municipal Agriculturist is hereby abolished;

Section 2. All rights, responsibilities and functions vested in the position of Agricultural Technician I, Salary Grade VI shall be transferred to the appropriate existing positions within the Office of the Municipal Agriculturist;

Section 3. Any personnel previously holding the position of Agricultural Technician, Salary Grade VI shall be reassigned to other suitable positions within the municipality's organizational structure;

Section 4. This ordinance shall take effect immediately upon its approval and publication as required by law.

ENACTED AND APPROVED on this 14TH day of February, 2024, during the 66TH Regular Session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
