EXCERPT FROM THE MINUTES OF THE 5TH REGULAR SESSION OF THE 6TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON AUGUST 8, 2007.

Resolution No. 270820

WHEREAS, Dr. Hermeraldo M. Catubig, Doctors to the Barrio assigned in the municipality of San Pablo, Zamboanga del Sur reported for duty last July, 2007;

WHEREAS, the amount of Fifty two thousand three hundred twenty pesos (P52,320.00) was requested for payment of his honorarium from July 1, 2007 to December 31, 2007 at Eight Thousand Seven Hundred Twenty Pesos (8,720.00) per month;

WHEREFORE, on motion by Hon. Noel T. Requillo, severally seconded, it was

RESOLVED, to revert, as it is hereby reverted, to ordain, as it is hereby ordained;

APPROPRIATION ORDINANCE NO. 27-0806

- Section 1. This Appropriation Ordinance shall be entitled "REVERSION AND RE-APPROPRIATION OF FUNDS".
- Section 2. Sources of funds shall betaken from the vacant funded position of Municipal Health Officer from July 1, 2007 to December 31, 2007, amounting Fifty two thousand six hundred pesos (P52,600.00) as per joint certification dated August 7, 2007.
- Section 3. The total amount of Fifty Two Thousand Three Hundred Twenty Pesos (P52,320.00) shall be re-appropriated for payment of Honorarium of Dr. Hermeraldo M. Catubig, Jr., Doctors to the Barrio assigned in the Municipality of San Pablo, Zamboanga del Sur, covering the period from July 1, 2007 to December 31, 2007 at Eight Thousand Seven Hundred Twenty Pesos (8,720.00) per month.
- Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Hon. Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing or repealing any part hereof in line with the established policies, guidelines, laws and regulations enforce.
