RESOLUTION NO. 271152

WHEREAS, MDC Resolution No. 051107, dated September 6, 2007, realigning different programs under the current Annual Investment Plan was submitted for the Body's immediate action and adoption;

WHEREAS, the total amount of Ninety Thousand pesos (P90,000.00) from 2007 AIP Project code 80-1-1 entitled "Counterpart Fund for the Electrification Program" shall be utilized for the Purchase of Mechanical Corn Sheller.

APPROPRIATION ORDINANCE NO. 07-1213

Section 1. This Appropriation Ordinance shall be entitled "MDC Realignment of Appropriation".

Section 2. Sources of funds shall be taken from AIP Project code 80-1-1 entitled "Counterpart Fund for the Electrification Program"

Section 3. The total amount of ninety Thousand pesos (P90,000.00) shall be utilized for the purchase of Mechanical Corn Sheller.

Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws and regulations enforce.
