APPROPRIATION ORDINANCE NO. 28-2023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF ONE HUNDRED FIFTY ONE THOUSAND PESOS (P151,000.00) FROM THE APPROPRIATION FOR REPRESENTATION EXPENSES UNDER THE OFFICE OF THE MUNICIPAL VICE MAYOR TO OTHER SUPPLIES EXPENSES CODE 765, OFFICE SUPPLIES EXPENSES CODE 755 AND OTHER MOOE CODE 969 OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Representation Expenses under the office of the Municipal Vice Mayor, San Pablo, Zamboanga del Sur, for CY 2023;

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
