EXCERPT FROM THE MINUTES OF THE 19TH REGULAR SESSION OF THE 6TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON MARCH 12, 2008.

RESOLUTION NO. 280382

WHEREAS, there is a substantial amount appropriated for Marine Protected Area (MPA) under item 80-5-1 of the 2007 Annual Investment Plan (AIP);

WHEREAS, the program involve the implementation of Management Program such as Organizational Administration, Information Education Campaign, Site Development, Habitat Enhancement and Environmental Protection, Law Enforcement and Policy support, Capability Building and the Monitoring and Evaluation;

WHEREAS, the total amount of One Hundred Forty Four Thousand Four Hundred Seventy (P144,470.00) remains unexpended and was recorded as continuing appropriation for this year 2008;

WHEREAS, the Body agreed to re-appropriate the same as additional funds for Information Education Campaign (IEC) under the same program of the MPA.

WHEREFORE, on motion by Hon. Erlinda P. Castillo, duly seconded by Hon. Retuya, be it

RESOLVED, TO APPROPRIATE, AS IT IS HEREBY APPROPRIATED, TO ORDAIN, AS IT IS HEREBY ORDAINED:

APPROPRIATION ORDINANCE NO. 08-0323

Section 1. This appropriation ordinance shall be called "Re-appropriation of funds."

Section 2. The total amount of One Hundred Forty Four Thousand Four Hundred Seventy (P144,470.00) shall be re-appropriated as additional fund for the IEC.

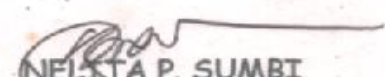
