RESOLUTION NO. 2812145

WHEREAS, a joint certification was issued, certifying the total amount of One Hundred Forty Seven Thousand Three Hundred Eleven pesos and Forty Four Centavos (P147,311.44) as PS savings of the vacant positions of Municipal Health Officer, Municipal Accountant, HRMO III from October to November, 2008;

WHEREAS, the total amount shall be utilized to augment appropriation for repair and maintenance and other operating expenses of the office of the Mun. Vice Mayor and partial payment for the staff house in Dao Pagadian City

RESOLVED to transfer, as it is hereby transferred, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 08-1135

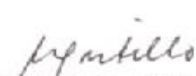

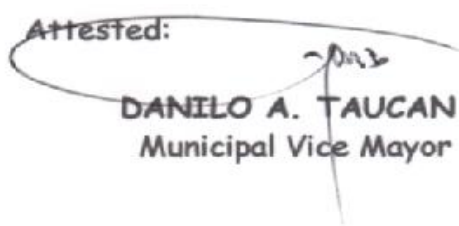
