MUNICIPAL ORDINANCE NO. 29-11

"AN ORDINANCE CREATING THE POSITION OF MEDICAL TECHNOLOGIST II, SALARY GRADE 15 UNDER MUNICIPAL HEALTH OFFICE, SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED by the 11TH Sangguniang Bayan of San Pablo, Zamboanga del Sur on its 76TH Regular Session held at the Municipal Session Hall on May 29, 2024 at 9:00 o'clock in the morning.

Section 1. Title – This ordinance shall be known as an "Ordinance Creating the position of Medical Technologist II, Salary Grade 15, in the Municipal Health Office, San Pablo, Zamboanga del Sur.

Section 2. Purpose – The purpose of this ordinance is to establish and create the position of Medical Technologist II, Salary Grade 15 in the municipality of San Pablo to enhance the delivery of medical services, improve healthcare efficiency, and ensure the availability of qualified medical professionals in our municipality;

Section 3. Position Creation – The position of Medical Technologist II, Salary Grade 15 is hereby created in the municipality of San Pablo, Zamboanga del Sur. The said position shall be under the administrative jurisdiction of the Municipal Health Officer, in the Municipal Health Office.

Section 4. Source of Fund - Appropriation Ordinance No. 06-2024

Section 5. Qualifications – The following qualifications are required for the position of Medical Technologist II, Salary Grade 15:

Section 6. Duties and Responsibilities – The Medical Technologist II, Salary Grade 15 shall have the following duties and responsibilities:

- a) Conduct various laboratory tests, analyses, and procedures, provide accurate and reliable results.
- b) Ensure compliance with established procedures, protocols and quality control standards.

- c) Analyze and interpret laboratory results, preparing detailed reports and recommendations for further medical intervention.
- d) Operate and maintain laboratory equipment and instruments.
- e) Collaborate with other medical professionals to provide comprehensive patient
- f) Update knowledge and skills through continuous professional development.
- g) Perform other related tasks as directed by superiors.

Section 7. Compensation - The Medical Technologist II, Salary Grade 15, shall receive a monthly compensation equivalent to Salary grade 15 in a 4th class municipality as provided in the Local Government Code of the Philippines, in accordance with the annual budget approved by the Sangguniang Bayan of San Pablo, Zamboanga del Sur.

Section 8. Implementation – This ordinance shall be implemented 15 days after publication.

Section 9. Repealing Clause - All previous ordinances, resolutions or parts thereof that are inconsistent with this ordinance are hereby repealed or modified accordingly.

Section 10. Separability Clause - If any provision of this ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

Section 11. Effectivity Clause - This ordinance shall take effect immediately upon approval.
