EXCERPT FROM THE MINUTES OF THE 2ND SPECIAL SESSION OF THE 6TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON MARCH 16, 2009.

RESOLUTION NO. 2903031

WHEREAS, a confirmation was made about the President's visit to the municipality of San Pablo in response to the invitation made by the Municipal Officials purposely for the President to witness the current situation of the Provincial road condition from San Pablo to Canuman, Guipos;

WHEREAS, the initial appropriation of Two Hundred Thousand is not enough to cover the necessary expenses of the said occasion;

WHEREAS, there is an available appropriation supposedly intended for payment of salary differential of the municipal Officials and Employees from July, 2008 to December, 2008;

WHEREFORE, On motion by Hon. Merlou A. Dela Peña, severally seconded, be it:

RESOLVED to appropriate, as it is hereby appropriated, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 09-0303

Section 1. This Appropriation Ordinance shall be entitled "Re-appropriation of funds"

Section 2. Out from the total amount of Eight Hundred Sixty One Thousand Three Hundred Two Pesos and Eighty Four Centavos (P861,302.84), the total amount of Seven Hundred Fifty Eight Thousand Three Hundred Two Pesos and Eighty Four Centavos (P758,302.84) is hereby properly appropriated to wit:

Additional Funds for President's visit	P558,302.84
Operation and Maintenance of KALAHI-CIDSS Program	200,000.00
Total	<u>P758,302.84</u>

Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws and regulations enforce.

ENACTED AND APPROVED on this 16TH day of March, 2009, during the 2ND Special Session for 2009 of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.

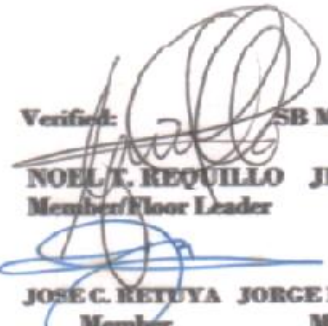

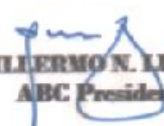

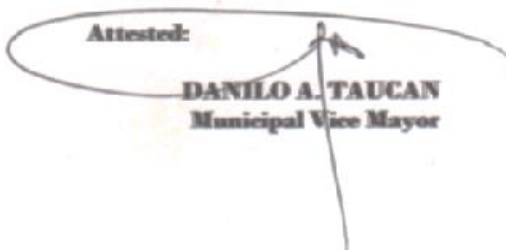
