EXCERPT FROM THE MINUTES OF THE 5TH REGULAR SESSION OF THE 6TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON MARCH 25, 2009.

RESOLUTION NO. 2903032

WHEREAS, a joint certification was issued, certifying the total amount of One Million Seven Hundred Seventy One Thousand Eight Hundred Sixty Seven Pesos and Five Centavos (P1,771,867.05) as the current surplus for CY 2008;

WHEREAS, the Local Officials have agreed to utilize the said amount for the purchase of one (1) unit vehicle for use by the Executive and the legislative Department since the two (2) units vehicles purchased for use to these Departments some few years ago is already unserviceable and will spend big amount for general repair.

WHEREFORE, on motion by Hon. Erlinda P. Castillo, severally seconded, be it:

RESOLVED to appropriate, as it is hereby appropriated, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 09-0304

Section 1. This Appropriation Ordinance shall be entitled "Appropriation of funds"

Section 2. The total amount of One Million Seven Hundred Seventy One Thousand Eight Hundred Sixty Seven Pesos and Five Centavos (P1,771,867.05) from the current surplus for CY 2008 is hereby properly appropriated for the ff:

1. Purchase of One (1) unit Service vehicle for use by the Local Officials of San Pablo, Zamboanga del Sur	P1,560,000.00
2. Purchase of 3 units laptop computer w/ accessories	153,550.00
3. Repair & Maintenance of vehicle (LCEO)	<u>58,317.05</u>
Total	P1,771,867.05

Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws and regulations enforce.

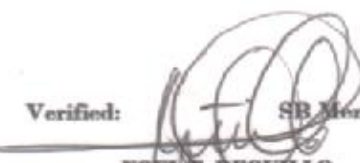

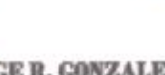

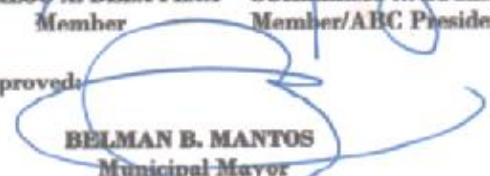
