RESOLUTION NO. 2907052

WHEREAS, the Local Finance Committee (LFC) jointly certified available funds amounting Five Hundred One Thousand thirteen pesos and Eighty Centavos (P501,013.80) as Gross IRA Difference for the month of June, 2009;

WHEREAS, there is an on-going implementation of the Ecological Solid Waste Management Program of the municipality of San Pablo with the assistance of all Barangay Captains and the Purok Officials in the entire municipality;

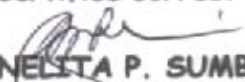
amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws and regulations enforce.

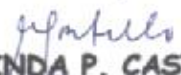
