APPROPRIATION ORDINANCE NO. 09-0809

Section 1. This appropriation ordinance shall be called "Savings from various vacant positions":

Section 2. Sources of funds shall be taken from the PS savings of the following offices:

1. HRMO III (June-August 2009)	P59,929.02
2. Municipal Accountant	76,613.04
3. Draftsman III	<u>46,663.86</u>
	<u>P183,205.92</u>

Section 3. The total amount of One Hundred Eighty Three Thousand Two Hundred Five Pesos and Ninety Two Centavos (P183,205.92) shall be used as additional appropriation for travel of the Local Chief Executive office (LCEO).

Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws and regulations enforce.
