## APPROPRIATION ORDINANCE NO. 09-1013

Section 1. This appropriation ordinance shall be called "APPROPRIATION OF FUNDS":

Section 2. Sources of Funds. Sources of funds shall be taken from the IRA MONETIZATION from 2001 and 2004 as jointly certified by the Municipal Accountant and the Municipal Treasurer and likewise approved by the Municipal Mayor.

Section 3. The total certified amount, shall be appropriated for drainage construction at Mialim Creek, Quezon Avenue and Ramon Magsaysay Street to wit:
