EXCERPT FROM THE MINUTES OF THE 18TH REGULAR SESSION OF THE 6TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON OCTOBER 28, 2009.

RESOLUTION NO. 2910076

WHEREAS, there is an available amount for appropriation from the IRA monetization received from 2001 to 2004 that can be used for different programs, projects and activities of the LGU;

WHEREAS, the Body agreed to utilize the said amount for drainage construction along different streets of San Pablo particularly at Ramon Magsaysay street to Purok Malinawon and Marcos Village;

WHEREFORE, on motion by Hon. Erlinda P. Castillo, severally seconded, be it

RESOLVED TO APPROPRIATE, as it is hereby appropriated, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 09-1013

Section 1. This appropriation ordinance shall be called "**APPROPRIATION OF FUNDS**":

Section 2. Sources of Funds. Sources of funds shall be taken from the **IRA MONETIZATION** from 2001 and 2004 as jointly certified by the Municipal Accountant and the Municipal Treasurer and likewise approved by the Municipal Mayor.

Section 3. The total certified amount, shall be appropriated for drainage construction at Mialim Creek, Quezon Avenue and Ramon Magsaysay Street to wit:

1. Canal at Mialim Creek (150m)	P350,000.00
2. Quezon Avenue	500,000.00
3. Ramon Magsaysay street to Purok Malinawon	434,000.00
4. Ramon Magsaysay street to Marcos Village	<u>950,000.00</u>
TOTAL APPROPRIATION	<u>P2,234,000.00</u>

Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws and regulations enforce.
