APPROPRIATION ORDINANCE NO. 31-2022

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF EIGHTY FOUR THOUSAND SIX HUNDRED PESOS (P84,600.00) FROM THE APPROPRIATION FOR PRINTING AND BINDING EXPENSES; REPAIR AND MAINTENANCE -AMBULANCE AND SAKYANAN NI NANAY AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO SPECIAL PROGRAM/WIRELESS ACCESS FOR **HEALTH OF THE SAME OFFICE."**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL **SUR IN SESSION ASSEMBLED:**

Section 1. There is an appropriation for Printing and Binding Expenses and Repair and Maintenance - Ambulance and Sakyanan ni Nanay and other MOOE under the Office of the Municipal Health Officer, San Pablo, Zamboanga Del Sur, for CY 2022;
