APPROPRIATION ORDINANCE NO. 32-2022

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIFTY ONE THOUSAND FOUR HUNDRED PESOS (P51,400.00) FROM THE APPROPRIATION FOR DRUGS AND MEDICINES EXPENSES AND GASOLINE, OIL & LUBRICANTS UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO OTHER MOOE AND OTHER SUPPLIES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIAN BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Drugs and Medicines Expenses and Gasoline, Oil and Lubricants under the Office of the Municipal Health Officer, San Pablo, Zamboanga Del Sur, for CY 2022;

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan, this 7TH day of December, 2022, during the 18TH Regular session of the Honorable Sangguniang Bayan of San Pablo, Zamboanga del Sur.
