APPROPRIATION ORDINANCE NO. 32-2023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWENTY THOUSAND THREE HUNDRED FIFTY-FIVE PESOS (20,355.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES, OTHER SUPPLIES EXPENSES, TELEPHONE EXPENSES – MOBILE, REPAIR AND MAINTENANCE – IT EQUIPMENT AND SOFTWARE AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL CIVIL REGISTRAR (MCR) TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **OFFICE SUPPLIES, OTHER SUPPLIES EXPENSES, TELEPHONE EXPENSES – MOBILE, REPAIR AND MAINTENANCE – IT EQUIPMENT AND SOFTWARE AND OTHER MOOE** under the office of the Municipal Civil Registrar, San Pablo, Zamboanga del Sur, for CY 2023;

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
