APPROPRIATION ORDINANCE NO. 33-2023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF NINETY SIX THOUSAND FIVE HUNDRED PESOS (96,500.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE – IT EQUIPMENT, REPAIR AND MAINTENANCE – AMBULANCE & SAKYANAN NI NANAY, AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER (MHO) TO OTHER SUPPLIES AND OFFICE SUPPLIES & MATERIALS OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **REPAIR AND MAINTENANCE – IT EQUIPMENT, REPAIR AND MAINTENANCE – AMBULANCE & SAKYANAN NI NANAY, AND OTHER MOOE** under the office of the Municipal Health Officer, San Pablo, Zamboanga del Sur, for CY 2023;

Section 3. Transfer/Augment of Item. Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
