## **APPROPRIATION ORDINANCE NO. 33-2024**

"AN ORDINANCE REALIGNING THE TOTAL AMOUNT OF ONE HUNDRED EIGHTY-FIVE THOUSAND PESOS (P185,000.00) FROM THE APPROPRIATION FOR GAD ACTIVITY AND BUDGET TO ESTABLISH AND MAINTAIN A LOCAL REGISTRY OF CULTURAL PROPERTY; ACCREDITATION PROCEDURES AND GUIDELINES AND SCHOOLS OF LIVING TRADITION BUDGET TO REPAIR/REHABILITATION OF KAPAMANOK ELEMENTARY SCHOOL BUILDING."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

- Section 1. There is an appropriation for GAD ACTIVITY AND BUDGET TO ESTABLISH AND MAINTAIN A LOCAL REGISTRY OF CULTURAL PROPERTY; ACCREDITATION PROCEDURES AND GUIDELINES AND SCHOOLS OF LIVING TRADITION in the 2024 GAD Activities and Budget;
- Section 2. The total amount of ONE HUNDRED EIGHTY-FIVE THOUSAND PESOS (P185,000.00) shall be REALIGNED for the Repair/Rehabilitation of kapamanok Elementary School Building to wit:

- **Section 4.** Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
- **Section 5.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
