APPROPRIATION ORDINANCE NO. 34-2023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIFTY EIGHT THOUSAND SIX HUNDRED SIXTY SIX PESOS (58,666.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES, PRINTING & BINDING EXPENSES AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR (MPDC) TO TRAVELLING EXPENSES OF THE SAME OFFICE."
BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **OFFICE SUPPLIES, AND PRINTING & BINDING and OTHER MOOE** under the office of the MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR (MPDC), San Pablo, Zamboanga del Sur, for CY 2023;

Section 2. The total amount shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
