## **APPROPRIATION ORDINANCE NO. 37-2023**

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FORTY-SIX THOUSAND PESOS (46,000.00) FROM THE APPROPRIATION FOR OTHER SUPPLIES; PRINTING & BINDING EXPENSES; AND REPAIR & MAINTENANCE-OFFICE EQUIPMENT UNDER THE OFFICE OF THE SANGGUNIAN SECRETARY TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for OTHER SUPPLIES; PRINTING & BINDING EXPENSES AND REPAIR & MAINTENANCE-OFFICE EQUIPMENT under the office of the Sanggunian Secretary, San Pablo, Zamboanga del Sur, for CY 2023;

**Section 3.** Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
