APPROPRIATION ORDINANCE NO. 44-2025

"AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1 OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR WITH A TOTAL AMOUNT OF TWENTY-SEVEN THOUSAND TWENTY EIGHT PESOS AND FIFTY SEVEN CENTAVOS (P27,028.57)."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

- **Section 1.** This appropriation Ordinance shall be entitled **Supplemental Budget No. 1** of the General Fund for CY 2025 of San Pablo, Zamboanga del Sur.
- Section 2. Sources of Appropriation shall be taken from the funded vacant item of Local Legislative Staff Officer III, for the period January 1-31, 2025, office of the Sanggunian Secretary in the amount of Twenty-Eight Thousand Nine Hundred Fifty Five Pesos and Eighty Two Centavos (P28,955.82).

Total Personal Services P27,028.57
Total Supplemental Appropriation

Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
