APPROPRIATION ORDINANCE NO. 44-2025

"AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1 OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR WITH A TOTAL AMOUNT OF TWENTY-SEVEN THOUSAND TWENTY EIGHT PESOS AND FIFTY SEVEN CENTAVOS (P27,028.57)."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. This appropriation Ordinance shall be entitled **Supplemental Budget No. 1** of the General Fund for CY 2025 of San Pablo, Zamboanga del Sur.

Section 2. Sources of Appropriation shall be taken from the funded vacant item of **Local Legislative Staff Officer III**, for the period **January 1-31, 2025**, office of the Sanggunian Secretary in the amount of **Twenty-Eight Thousand Nine Hundred Fifty Five Pesos and Eighty Two Centavos (P28,955.82)**.
