## **APPROPRIATION ORDINANCE NO. 46-2023**

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT EIGHTY THOUSAND FIVE HUNDRED FIFTY SIX PESOS (P80,556.00) FROM THE APPROPRIATION FOR OTHER SUPPLIES AND OTHER MOOE UNDER THE OFFICE OF THE SANGGUNIANG BAYAN TO REPRESENTATION EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

**Section 1.** There is an appropriation for **OTHER SUPPLIES AND OTHER MOOE** under the office of the Sangguniang Bayan, San Pablo, Zamboanga del Sur, for CY 2023;

**Section 2.** The total amount of Eighty Thousand Five Hundred Fifty Six Pesos (P80,556.00) shall be transferred to wit:

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
