"A RESOLUTION ENDORSING THE PRIORITY PROGRAMS AND PROJECTS OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THRU THE DBM SECRETARY WENDEL E. AVISADO."

WHEREAS, the Department of Budget and Management (DBM) thru LBC No. 119 dated July 15, 2019 set guidelines on the release and utilization of the Local Government Support Fund-Other Financial Assistance to Local Government Units in the FY 2019 General Appropriations Act, Republic Act No. 11260;

WHEREAS, article 100 (1) (iv) of the Local Government Code of 1991 states that the Sangguniang Bayan as a Legislative Body of the municipality shall adopt measures to protect the inhabitants from harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;

WHEREAS, the DBM also appropriated an amount which shall be used for financial assistance to local government units to support its priority programs and projects;

WHEREAS, the of San Pablo, Zamboanga del Sur have chosen the following projects:

Installation of Municipal street Light of Poblacion	9,826,194.53
2. Construction of Core Local Access Road, Sagasan - San Juan Road	9,749.343.87
3. Construction of Core Local Access Road, Kondum-Lumbayao Road	9,582,524:91
4. Construction of Core Local Access Road, Kondum-Lumbayao Road	9,668,957.76
5. Construction of Core Local Access Road, Kondum-Lumbayao Road	9,563,067.36
