RESOLUTION NO. 07-0321

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, OF SAN PABLO, ZAMBOANGA DEL SUR, HON. DANILO A. TAUCAN, TO ENTER INTO MEMORANDUM OF AGREENMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE IMPLEMENTATION OF STRENTHENING COMMUNITY PARTICIPATION IN LOCAL DEVELOPMENT (KALAHI-CIDSS NCDDP)."

WHEREAS, a copy of the letter from DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE IX, was furnished to this office, informing that San Pablo, Zamboanga del Sur is one of the approved municipalities for KALAHI-CIDSS NCDDP training with grant provision;

WHEREAS, pursuant to the agreement, one of the Roles and Responsibilities of the DSWD is to provide grants for community sub-projects, identifies through a participatory and transparent and open process, following KALAHI-CIDSS NCDDP and Program guidelines for the purpose;

WHEREAS, the LGU of San Pablo in return shall allocate a local counterpart funds, in cash or in kind, provide technical support to barangays, enjoined its barangays to adopt and apply CDD-based tools, platforms and the 4 CDD-based thematic modules which is Participatory Situation Analysis; Community-Based Finance and Community-based Monitoring.

WHEREFORE, on motion by Hon. Erlinda P. Castillo, duly seconded by Artemio C. Dayondon, be it

RESOLVED, as it hereby resolved, authorizing the Municipal Mayor, Hon. Danilo A. Taucan of San Pablo, Zamboanga del Sur to enter into Memorandum with the DSWD for the implementation of Strengthening Community Participation in Local Development (KALAHI-CIDSS NCDDP).
