**"A RESOLUTION REQUESTING FUNDS FROM HON. ANDREA D. DOMINGO, CHAIRMAN AND CHIEF EXECUTIVE, PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR), FOR THE CONSTRUCTION OF EVACUATION CENTER AT THE MUNICIPAL AREA, POBLACION, SAN PABLO, ZAMBOANGA DEL SUR."**

**WHEREAS**, the municipality of San Pablo is a 4<sup>TH</sup> class municipality situated in the 2<sup>nd</sup> Congressional District of Zamboanga del Sur;

**WHEREAS**, the topographic nature and the geographical location of our municipality render the community vulnerable to the natural hazards of typhoon/severe weather disturbances, flooding, mass movements and earthquake;

**WHEREAS**, Geohazard assessments classifies that majority of our upland barangays are highly susceptible to landslides while our plain and flat areas are susceptible to severe flooding during heavy rains;

**WHEREAS**, our municipality is in need of an Infrastructure, capable to support and provide shelter for temporary displaced families in times of disaster, which will also serve as venue for the conduct of drills, trainings and other disaster preparedness activities.

**WHEREFORE**, on motion by Hon. Jezreel G. Abelidas, severally seconded, be it

**RESOLVED**, as it is hereby resolved, requesting funding from Hon. Andrea D. Domingo, Chairman and Chief Executive of Philippine Amusement and Gaming Corporation (PAGCOR), 1330 Prayer House, Roxas Boulevard, Ermita, Manila for the construction of Evacuation Center at the Municipal Area, Poblacion, San Pablo, Zamboanga del Sur."
