**"A RESOLUTION REQUESTING HON. RICARDO R. VISAYA, ADMINISTRATOR, NATIONAL IRRIGATION ADMINISTRATION, EDSA, DILIMAN, QUEZON CITY, FUNDS FOR FLOOD CONTROL PROJECT AT MALBOG RIVER AND MIALIM CREEK, POBLACION, SAN PABLO, ZAMBOANGA DEL SUR."**

**WHEREAS**, Flash floods and overflowing waters always bring destruction to lives and causes extensive damage to agricultural properties come rainy season, especially when accompanied by typhoons;

**WHEREAS**, our municipality is in need of a flood control project in order to prevent if not completely stopped the on-rushing flood waters to residential and crops plantation areas.

**RESOLVED**, as it is hereby resolved, requesting Hon. Ricardo R. Visaya, Administrator, National Irrigation Administration, Edsa, Diliman, Quezon City, Funds for Flood Control Project at Malbog River and Mialim Creek, Poblacion, San Pablo, Zamboanga del Sur."
