RESOLUTION NO. 10-0421

"A RESOLUTION REQUESTING PERMISSION FROM THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) TO CUT SOME AFFECTED MAHOGANY TREES LOCATED IN FRONT OF THE MUNICIPAL BUILDING, LGU, SAN PABLO, ZAMBOANGA DEL SUR, FOR THE CONSTRUCTION OF PEOPLES PARK."

WHEREAS, one of the priority projects of the Municipal Officials of San Pablo, Zamboanga del Sur for CY 2021 is beautification which is a key aspect of community development, in addition to on-going Infrastructure projects like the IBT- cum Public Market which is located at the heart of Poblacion, the Rehabilitation of Rebi Beach Resort at Barangay Teniapan, and some Roads Repair program;

WHEREAS, a visually appealing community increases property values, attract investors and visitors looking for a pleasant place to stay;

WHEREAS, the Municipal Officials of LGU San Pablo, Zamboanga del Sur have appropriated funds for the construction of Peoples Park in front of the Municipal Building;

WHEREAS, there are some Mahogany Trees aging 10 years or more in the project site that can possibly be affected of the People's Park project.

WHEREFORE, on motion by Hon. Allan S. Ceño, severally seconded, be it

RESOLVED, as it is hereby resolved, **requesting permission from the Department of Environment and Natural Resources (DENR) to cut come affected Mahogany Trees located in front of the Municipal Building, LGU, San Pablo, Zamboanga del Sur."**
