RESOLUTION NO. 19-0721

"A RESOLUTION RESPECTFULLY ENDORSING THE PROPOSED INFRASTRUCTURE PROJECT OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR TO BE FUNDED BY THE LOCAL GOVERNMENT SUPPORT FUND (LGSF) UNDER THE DEPARTMENT OF BUDGET AND MANAGEMENT."

WHEREAS, the San Pablo Municipal Development Council has identified various Infrastructure projects that will contribute to the economic development of the municipality of San Pablo, Zamboanga del Sur;

WHEREAS, the proposed infrastructure projects was adopted by the Sangguniang Bayan and the same was included as one of the priority projects of this municipality;

WHEREAS, funds for the proposed projects will be culled from the Local sources, and National Budgets particularly from the Local Government Support Fund under the Department of Budget and Management;

WHEREAS, one of the requirements for the release of the Local Government Support Fund is a Sangguniang Bayan Resolution endorsing the projects being proposed for implementation.

WHEREFORE, on motion by Hon. Jonathan B. Medico, severally seconded, be it

RESOLVED, as it is hereby resolved, to endorse to the Department of Budget and Management (DBM), construction of River Control along Malbog River project of the municipality of San Pablo, Zamboanga del Sur, amounting **Fifty Million Pesos (P50,000,000.00)** for funding under the Local Government Support Fund.


