EXCERPT FROM THE MINUTES OF THE 67TH REGULAR SESSION OF THE 10TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON JULY 14, 2021.

RESOLUTION NO. 20-0721

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN OF SAN PABLO, ZAMBOANGA DEL SUR, TO ENTER INTO CONTRACT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR SPECIFIC IMPLEMENTATION AGREEMENT (SIA)."

WHEREAS, in adherence to the 4Ps law, the Department of Social Welfare and Development (DSWD) and the partner LGUs are enjoined to have clear and targeted programs for the beneficiaries ensuring that their well-being is improved and not slide back to poverty;

WHEREAS, among the roles and responsibilities of the DSWD pursuant to this agreement is to advocate the implementation of 4Ps as the national poverty reduction and a human capital investment program that provides conditional cash transfer to qualified household – beneficiaries; identify and select the target household – beneficiaries based on a uniform, objective and transparent selection process as indicated in section 5 of the Pantawid act; and provide cash transfer to the identified and qualified program beneficiaries;

WHEREAS, in relation thereto, the LGU of San Pablo shall among others, take the lead in the passage of Local ordinance supporting the program implementation of 4Ps to improve the condition of its poor constituents; and ensure that supply-side requirements on infrastructure and manpower are adequate to meet the needed health services and ensuring that children beneficiaries have access to proper educational facilities are required by the program.

WHEREFORE, on motion by Hon. Erlinda P. Castillo, severally seconded, be it

RESOLVED, as it is hereby resolved, authorizing the Municipal Mayor, Hon. Danilo A. Taucan of San Pablo, Zamboanga del Sur, to enter into contract with the Department of Social Welfare and Development (DSWD) for Specific Implementation Agreement (SIA).
