RESOLUTION NO. 201004017

"A RESOLUTION REQUESTING THE SMART COMMUNICATION, INC. TO PAY THEIR TAX DELINQUENCY DUE TO THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, the Municipal Treasurer of this municipality forwarded to this office the statement of tax delinquency of the Smart Communication, Inc. the property located at Purok Maloloy-on, Barangay Poblacion, as declared per ARP NO. 03-20-001-0686 for the Building/Structure and ARP No. 03-20-001-0688 for Machinery with an Assessed Value of Two Million Seven Hundred Nineteen Thousand Two Hundred Sixty Pesos (P2,719,260.00) and Three Million Seven Hundred Twenty Seven Thousand One Hundred Sixty Pesos (P3,727,160.00) respectively;

WHEREAS, the total amount as per computation submitted for BASIC and SEF tax is Three Hundred Ninety Thousand Four Hundred Eighty Five Pesos and Seventy Two Centavos (P390,485.72) for the Building and Five Hundred Twenty Four Thousand Seven Hundred Eighty Eight Pesos and Ten Centavos (P524,788.10) for Machinery, a total of *Nine Hundred Fifteen Thousand Two Hundred Seventy Three Pesos and Eighty Two Centavos (P915,273.82)*.


WHEREFORE, on motion by Hon. Noel T. Requillo, duly seconded by Hon. Erlinda P. Castillo, be it

RESOLVED, as it is hereby resolved, requesting the SMART Communication, Inc. thru Ms. Rina R. Manuel, Tax Division, Smart Tower 6799, Ayala Avenue, Makati City to pay their tax Delinquency due to the Municipality of San Pablo, Zamboanga del Sur, as per Statement of Tax Delinquent attached.






