WHEREAS, there is an appropriation for the repair of SB Office amounting Sixty Thousand Pesos (P60,000.00) per supplemental budget no. 2 and appropriation ordinance no. 12-0506, dated May 2, 2012;

WHEREAS, the Body agreed to revert the said amount as Aid to Zamboanga del Sur Medical Center as Indigency fund.

RESOLVED, to appropriate, as it is hereby appropriated, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 12-0811

Section 1. This Appropriation ordinance shall be entitled "~~Transfer~~ of Appropriation"


Section 2. The total amount of Sixty Thousand Pesos (P60,000.00) appropriated for the repair of SB Office shall be reverted as Aid to Zamboanga del Sur Medical Center as Indigency Fund.

Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.




