EXCERPT FROM THE MINUTES OF THE 27TH REGULAR SESSION OF THE 8TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, (*Under the Local Government Code of 1991*) HELD AT THE SESSION HALL ON MAY 21, 2014.

RESOLUTION NO. 20140591

"A RESOLUTION EARNESTLY REQUESTING HON. GOV. ANTONIO H. CERILLES, CHAIRMAN OF THE PROVINCIAL SCHOOL BOARD, PROVINCE OF ZAMBOANGA DEL SUR TO FACILITATE THE RETENTION OF THE LOCAL PAID TEACHERS IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR"

WHEREAS, DepEd San Pablo District has twenty Seven (27) Elementary Schools, one (1) Primary School and Seven (7) National High Schools;

WHEREAS, to augment the need of Teachers both Elementary and Secondary, the Local School Board allocated funds for the Honorarium of Thirty Four (34) Local Paid Teachers;

WHEREAS, Fifteen (15) out of Twenty Eight (28) Schools are multi-grade classes;

WHEREAS, to achieve quality education, majority of classes both Elementary and Secondary are handled by Local Paid Teachers;

WHEREAS, just recently, DepEd Secretary Luistro issued Memorandum no. 006811, dated March 20, 2014, re: Discontinuation of the hiring of LGU Funded and Kindergarten Volunteer Teachers and reminder to hire only Qualified LGU-Funded and DepEd subsidized Teachers as of 2012 for SY 2014-2015.

WHEREAS, due to this Memorandum Order, Fifteen (15) Elementary Schools and Five (5) National High Schools in the municipality of San Pablo are very much affected due to the shortage of DepEd regular Teachers;

WHEREAS, Quality Education is very difficult to achieve if a Teacher is handling multi-grade classes and at the same time a School Head.

WHEREAS, San Pablo LGU is looking forward to address the shortage of regular Teachers thru deployment of Local Paid Teachers;

WHEREAS, School Form 3, (School Based Report on Teachers, Enrollment and Facilities) is duly attached for ready reference.

WHEREFORE, on motion by Hon. Erlinda P. Castillo, duly seconded by Hon. Roberto M. Aguilar, be it

RESOLVED, as it is hereby resolved, requesting Hon. Gov. Antonio H. Cerilles, Chairman of the Provincial School Board, Province of Zamboanga Del Sur to Facilitate the Retention Of the Local Paid Teachers in the Municipality of San Pablo, Zamboanga Del Sur"


