## **RESOLUTION NO. 201410169**

A RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF SAN PABLO, REPRESENTED BY THE MUNICIPAL MAYOR, HON. BELMAN B. MANTOS, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG), ZAMBOANGA DEL SUR PROVINCIAL OFFICE, AND THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) ZAMBOANGA DEL SUR PROVINCIAL OFFICE FOR THE IMPLEMENTATION OF THE BUSINESS PERMIT AND LICENCING SYSTEM (BPLS) IN SAN PABLO, AND TO APPROPRIATE FUNDS THEREFOR.

WHEREAS, in compliance to R.A. 9485, otherwise known as the Anti Red Tape Act (ARTA) of 2007, the government sets standards for processing Business Permits and Licenses issued by cities and municipalities aimed at improving efficiency in the business registration system and reducing the cost of doing business in the country;

WHEREAS, DILG-DTI Joint Memorandum Circular No. 1 series of 2010 dated August 06, 2010 sets guidelines in implementing the standards in processing business permits and licenses in all cities and municipalities;

WHEREAS, pursuant to item 4.0 BPLS Reform Standard, all cities and municipalities are enjoined to follow the standards in processing business permits and licenses;

WHEREAS, DILG and DTI have agreed to jointly undertake a project of assisting the cities and municipalities in streamlining the Business Permits and Licensing System;

WHEREAS, Trade and Industry Committee of the Sangguniang Bayan, after finding that the implementation of the BPLS will contribute to the reduction of the cost of doing business in the municipality of San Pablo, has endorsed to the august Sangguniang Bayan for the passage of the resolution.

WHEREFORE, on motion by Hon. Roberto M. Aguilar, duly seconded by Hon. Bienvenido E. Quirante, be it

RESOLVED, as it is hereby resolved, authorizing the Municipal Government of San Pablo, represented by the Municipal Mayor, <u>Hon. Belman B. Mantos</u> to enter into a Memorandum of Agreement (MOA) with the Department of Interior and Local Government (DILG), Zamboanga del Sur Provincial Office, and the Department of Trade and Industry-Zamboanga del Sur Provincial Office for the implementation of the Business Permit and Licensing System (BPLS) in the Municipality of <u>San Pablo</u>.
