EXCERPT FROM THE MINUTES OF THE 55TH REGULAR SESSION OF THE 8TH MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON OCTOBER 7, 2015.

RESOLUTION NO. 201510273

WHEREAS, joint certifications dated September 29, 2015 and October 5, 2015 was issued, certifying the total amount of **Seven Hundred Twenty Five Thousand Four Hundred Forty Nine Pesos and Seventy Two Centavos (P725,449.72)** representing amount reserved for Sangguniang Kabataan (SK) and the amount of **Four Hundred Eighty Six Thousand Two Hundred Twenty Five Pesos (P486,225.00)** representing PS savings from the vacant positions of **Clerk IV, Clerk 1, Accounting Clerk III, and RCC 1** for the months of January – October, 2015 which is available for appropriation;

WHEREAS, request for funding was presented for the different expenses related to the celebration of the Palarong Pambayan, 2015; Wages of 1 Casual Employee; Fuel, Oil & Lubricants; Other Supplies and Representation Expenses during the conduct of "Hatud Serbisyo sa Barangay", and other related expenses.

WHEREFORE, on motion by Hon. Roberto M. Aguilar, duly seconded by Hon. Jorge R. Gonzales, be it

RESOLVED, to appropriate, as it is hereby appropriated, to ordain as it is hereby ordained:

Appropriation Ordinance No. 15-1005

Section 1. This Appropriation ordinance shall be entitled "**Appropriation of Funds**"

Section 2. The total amount of One Million Two Hundred Eleven Thousand Six Hundred Seventy Four Pesos and Seventy Two Centavos (P1,211,674.72) is hereby properly appropriated for the following:


1. Wages of 1 Driver casual employee	- P 31,800.00
2. Fuel, Oil & Lubricants	- 100,000.00
3. Other Supplies Expenses	- 461,511.78
4. Representation Expenses	- 483,362.94
5. Palarong Pambayan, 2015	- <u>135,000.00</u>
TOTAL	<u>P1,211,674.72</u>

Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.


