RESOLUTION NO. 20170371

"A RESOLUTION AUTHORIZING THE MUNICIPAL VICE MAYOR, HON. ROBERTO M. AGUILAR AND THE OIC MUNICIPAL TREASURER, MRS. LILIA T. PALOMA AS THE OFFICIAL SIGNATORY UNDER THE LEGISLATIVE DEPARTMENT OF SAN PABLO, ZAMBOANGA DEL SUR IN ITS BANKING TRANSACTION AT DEVELOPMENT BANK OF THE PHILIPPINES (DBP) PAGADIAN BRANCH, PAGADIAN CITY".

WHEREAS, safeguarding of Local Government funds is one of the many concerns of the new set of Municipal Officials of San Pablo, Zamboanga del Sur;

WHEREAS, the OIC Regional Director, Bureau of Local Government Finance, Regional Office IX, issued a Relief Order dated March 20, 2017 to Ms. Maria Alicia C. Providencia as Municipal Treasurer of San Pablo, Zamboanga del Sur effective March 17, 2017;

WHEREAS, on March 20, 2017, a BLGF-IX Regional Special Personnel Order no. 2017-035, was also issued, designating Mrs. Lilia T. Paloma, LRCO II, Office of the Municipal Treasurer, San Pablo, Zamboanga del Sur as the OIC Municipal Treasurer, effective March 20, 2017 to March 19, 2018;

WHEREAS, in order not to hamper the delivery of basic services to the people of San Pablo, Zamboanga del Sur, it is in dire need that the signatory of the municipality's bank transaction under the Legislative Department be changed favorably to the Hon. Vice Mayor Roberto M. Aguilar and the OIC Municipal Treasurer, Mrs. Lilia T. Paloma, LRCO II.

WHEREFORE, on motion by Hon. Jonathan B. Medico, duly seconded by Hon. Artemio C. Dayondon, be it

RESOLVED, as it is hereby resolved, authorizing the **Municipal Vice Mayor, Hon. Roberto M. Aguilar**, and the OIC Municipal Treasurer, Mrs. Lilia T. Paloma as official signatory in the **Legislative Department** of San Pablo, Zamboanga del Sur in all its banking transaction at Development Bank of the Philippines (DBP) Pagadian Branch, Pagadian City.
