**RESOLUTION NO. 20170585**

**"A RESOLUTION WAIVING THE REQUIREMENTS OF BUILDING PERMIT AND ELECTRICAL PERMIT FOR THE NEW APPLICANTS-HOUSEHOLD BENEFICIARIES UNDER THE NATIONWIDE INTENSIFICATION HOUSEHOLD ELECTRIFICATION (NIHE) PROGRAM OF THE DEPARTMENT OF ENERGY (DOE)."**

**WHEREAS**, the President of the Republic of the Philippines, President Rodrigo R. Duterte urges to help avoid squatter-like conditions in relocation sites, urging utilities like Meralco and electric cooperatives to exercise their social corporate responsibilities by making direct connections to relocation sites and depressed areas;

**WHEREAS**, the Department of Energy has embarked on a nationwide intensification household electrification program targeting indigent citizens especially those living in remote areas;

**WHEREAS**, qualified households are those situated on areas where the distribution facilities are physically and technically available for service connections provided and subsidized by the Department of Energy to defray the costs of house wiring, meter and service drop and other allowable fees at P3,750.00/household;

**WHEREFORE**, on motion by Hon. Mosiddic T. Calalagan, severally seconded, be it


**RESOLVED**, as it is hereby resolved, waiving the requirements of building permit and electrical permit for the new applicants-household beneficiaries, strongly supporting the implementation of the Nationwide intensification Household Electrification (NIHE) Program of the department of Energy.
