RESOLUTION NO. 201710122

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE SAN PABLO NATIONAL HIGH SCHOOL (SPNHS) FOR THE WORK IMMERSION PROGRAM RELATIVE TO THE IMPLEMENTATION OF ENHANCED BASIC EDUCATION ACT OF 2013 OR REPUBLIC ACT 10533."

WHEREAS, Paragraph 4, Section 2 of the Republic Act 9155 or "Governance of Basic Education Act of 2001", states that the LGU is encouraged to fully support the successful implementation of the K to 12 Program of the Department of Education;

WHEREAS, the Work Immersion Program is one of the course requirements for graduation, wherein a Senior High School Student has to undergo work immersion in a business organization or establishment so that they will be exposed to and are familiarized to their field of specialization;

WHEREAS, under the agreement, one of the responsibility of the LGU is to provide the students with an orientation about the LGU, the job as well as expose them to the various stakeholders of the community in which it operates for the students to get a holistic understanding of the LGU.

WHEREFORE, on motion by Hon. Erlinda P. Castillo, duly seconded by Hon. Artemio C. Dayondon, be it

RESOLVED, as it is hereby resolved, authorizing the Municipal Mayor, Hon. Danilo A. Taucan to enter into Memorandum of Agreement (MOA) with the San Pablo Zamboanga del Sur (SPNHS), San Pablo, Zamboanga del Sur for the Work Immersion Program, relative to the implementation of Enhanced Basic Education Act of 2013 or Republic Act 10533.

Let copies of this resolution be furnished to the Different Offices concerned for information and reference.


