WHEREAS, presented for consideration, Technical Description of the Municipal Waters of the Municipality of San Pablo, Province of Zamboanga del Sur for reference;

WHEREAS, the Municipal Mayors of the Five (5) coastal municipalities, namely: San Pablo, Dinas, Dimataling, Tabina and Pitogo, both in the Province of Zamboanga del Sur, agreed to establish the delineation/points of their respective municipal sea waters.
