RESOLUTION NO. 201808188

“A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN AND THE OIC MUNICIPAL TREASURER, MRS. DIONA W. WAMILDA AS THE OFFICIAL SIGNATORY OF SAN PABLO, ZAMBOANGA DEL SUR IN ALL ITS BANKING TRANSACTION AT DEVELOPMENT BANK OF THE PHILIPPINES (DBP) PAGADIAN BRANCH, PAGADIAN CITY”.

WHEREAS, safeguarding of Local Government funds is one of the many concerns of the Municipal Officials of San Pablo, Zamboanga del Sur;

WHEREAS, in view of the compulsory retirement of the former OIC Municipal Treasurer, Mrs. Lilia T. Paloma, the Municipal Mayor, Hon. Danilo A. Taucan issued a designation order to Ms. Diona W. Wamilda, Management & Audit Analyst III under the office of the Municipal Accountant, San Pablo, Zamboanga del Sur as the OIC Municipal Treasurer;

WHEREAS, the OIC Executive Director, Bureau of Local Government Finance, Regional Office IX, issued a BLGF SPECIAL PERSONNEL ORDER No. 018-2018 dated July 26, 2018 to Ms. Diona W. Wamilda as OIC Municipal Treasurer of San Pablo, Zamboanga del Sur effective July 18, 2018 to July 17, 2019;


WHEREAS, in order not to hamper the delivery of basic services to the people of San Pablo, Zamboanga del Sur, it is in dire need that the signatory of the municipality's bank transaction be changed favorably to the Hon. Mayor Danilo A. Taucan and the OIC Municipal Treasurer, Mrs. Diona W. Wamilda.

WHEREFORE, on motion by Hon. Mosiddic T. Calalagan, duly seconded by Hon. Erlinda P. Castillo, be it

RESOLVED, as it is hereby resolved, authorizing the Municipal Mayor, Hon. Danilo A. Taucan, and the OIC Municipal Treasurer, Mrs. Diona W. Wamilda as official signatory of San Pablo, Zamboanga del Sur in all its banking transaction at Development Bank of the Philippines (DBP) Pagadian Branch, Pagadian City.
