"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR OF SAN PABLO, ZAMBOANGA DEL SUR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE IMPLEMENTATION OF STRENGTHENING COMMUNITY PARTICIPATION IN LOCAL DEVELOPMENT (MAKILAHOK)."

WHEREAS, a copy of the letter from Maria Lourdes T. Jarabe, Undersecretary for Promotive Operations and Programs Group and Deputy Program Director and Officer-In-charge, KALAHI-CIDSS NCDDP, dated June 5, 2018 was furnished to this office, informing that San Pablo, Zamboanga del Sur is one of the approved municipalities for Makilahok training with grant provision;

WHEREAS, pursuant to the agreement, one of the Roles and Responsibilities of the DSWD is to provide grants for community sub-projects, identified through a participatory and transparent and open process, following Makilahok and Program guidelines for the purpose;

WHEREAS, the LGU of San Pablo in return shall allocate a local counterpart funds, in cash or in kind, provide technical support to barangays, enjoined its barangays to adopt and apply CDD-based tools, platforms and the 4 CDD- based thematic modules which is Participatory Situation Analysis; Community Procurement, Community-based Finance and Community-based monitoring.

WHEREFORE, on motion by Hon. Jonathan B. Medico, duly seconded by Hon. Artemio C. Dayondon, be it

RESOLVED, as it is hereby resolved, authorizing the Municipal Mayor, Hon. Danilo A. Taucan of San Pablo, Zamboanga del Sur to enter into Memorandum of Agreement with the DSWD for the implementation of Strengthening Community Participation in Local Development (**MAKILAHOK**).
