"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN AND THE OIC MUNICIPAL TREASURER, DIONA W. WAMILDA TO TRANSFER THE TOTAL AMOUNT OF SIXTY THOUSAND PESOS (P60,000.00) REPRESENTING APPROPRIATION FOR TAX MAPPING PROJECT THROUGH DIGITIZATION OF TAX MAPS, TO REGULAR TRUST FUND ACCOUNT 005520-840-3 OF SAN PABLO, ZAMBOANGA DEL SUR AT THE LAND BANK OF THE PHILIPPINES, PAGADIAN CITY BRANCH OFFICE".

Wamilda to transfer the total amount Sixty Thousand Pesos (P60,000.00) representing appropriation for Tax Mapping Project through Digitization of Tax Maps to regular Trust Fund Account 005520-840-3 of the municipality of San Pablo at the Land Bank of the Philippines (LBP) Pagadian City branch office.
