WHEREAS, the Municipal Disaster Risk Reduction & Management Investment Plan of the Municipality of San Pablo, Zamboanga del Sur for CY 2019 was submitted for review and adoption:

WHEREAS, the total amount of Five Million Thirty Eight Thousand Forty Four Pesos and Sixty Centavos (P5,038,044.60) was properly distributed as follows: 30% of the 5% total budget are appropriated for Quick Response amounting One Million Five Hundred Eleven Thousand Four Hundred Thirteen Pesos and Thirty Eight Centavos (P1,511,413.38) and 70% for Preparedness and efforts, amounting Three Million Five Hundred Twenty Six Thousand Six Hundred Thirty One Pesos and Twenty Two Centavos (P3,526,631.22) are appropriated for the following:

1. Rescue vehicle (HI-Lux)	-	P2,000,000.00
2. Rescue Boat(Rubberize Boat)	-	300,000.00
3. Supplies and Materials	-	56,631.22
4. Communication Services/Telephone Expenses	-	50,000.00
5. Travel	-	50,000.00
6. Desktop, Printer, Radio, Cellphone, Tablets Tables, chairs, Folding Beds, Portable Tents	-	200,000.00
7. (ICS, RDNA, PDNA, MSAR, A.L.S) Radio Operations & BERT	-	700,000.00
8. Assistance to Recovery, Rehabilitation Relocation of Displaced/Hazard Prone Families	-	120,000.00
9. Celebration of Fire Prevention month	-	<u>50,000.00</u>
