EXCERPT FROM THE MINUTES OF THE 98<sup>TH</sup> REGULAR SESSION OF THE 9<sup>TH</sup> MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON MAY 22, 2019.

RESOLUTION NO. 201905241

"A RESOLUTION REQUESTING POLICE CAPTAIN HERMINIGILDO P. BAJAO, JR., OIC, SAN PABLO, ZDS MUNICIPAL POLICE STATION, PROGRESS REPORT IN AID OF LEGISLATION, REGARDING THE EXPLOSION IN FRONT OF THE BUREAU OF FIRE PROTECTION (BFP) BUILDING AND THE BURNING OF THE UNCOUNTED BALLOTS AT THE SAN PABLO CENTRAL ELEMENTARY SCHOOL BUILDING LAST WEDNESDAY EVENING, MAY 15, 2019,".

WHEREAS, at around more or less 11:10 in the evening of May 15, 2019, explosion was heard from unidentified explosive device that was thrown in front of the Bureau of Fire Protection (BFP) building, few meters away from the PNP Station;

WHEREAS, few seconds after the explosion, burning was made at one of the two rooms in the San Pablo Central Elementary School building where the uncounted ballots of the eight (8) precincts including the counting machines were located also few meters away from the PNP Station;

WHEREAS, these two (2) frightening incident made the people of San Pablo panic specially those who served during the elections; the Teachers, the Watchers of both party, the electors and those who are in the vicinity observing during the counting, because of all the elections, there was no record of the same incident found in the history of elections in San Pablo, Zamboanga del Sur.

WHEREFORE, on motion by Hon. Allan S. Ceño, severally, be it

RESOLVED, as it is hereby resolved, requesting Police Captain Herminigildo P. Bajao, Jr., OIC, San Pablo ZDS Municipal Police Station, to give a Progress Report, in aid of Legislation, regarding the explosion in front of the BFP Building and the burning of uncounted ballots at the San Pablo Central Elementary School Building, both are just few meters away from the Police Station of San Pablo, Zamboanga del Sur that happened last Wednesday, May 15, 2019.

Let copies of this resolution be furnished to the concerned Agencies for information and appropriate action.
